9. The Client shall employ Creative Casting Agency for the project entitled " \_\_\_\_\_ " (hereinafter referred to as "*Project*").
10. Talent's services shall include:

11. All payments made by the Client to The Agency shall be made to "The Creativity Collective" and to the above stated address.
12. Talent will not be expected to man sound equipment, do heavy lifting or cleaning.
13. No fee shall be owed to The Creative Casting Agency if engagement is suspended by reason of National Mourning, Fire, Epidemic, War, Strikes, lockout or by reason of order of any Licensing or Public Authority.
14. Client agrees that all print and web promotion (that is available) must give credit to "The Creative Casting Agency" for providing talent services. This may be done by adding the Agency logo on the website as "additional talent services provided by The Creative Casting Agency." Print promotion should have the logo adjoined to any talent photos or write-ups on

posters, event schedules, brochures, fliers, banners, lanyards, and postcards. Talent shall be entitled to screen credit and/or mentions in print and web material.

15. If requested, The Creative Casting Agency will provide headshots, promo photos, bios and talent descriptions for Client's promotional use. Requests will be honored within two weeks
16. It is the Client's responsibility to provide a safe and clean area for talent to perform. Talent will not perform in areas that are unsafe, unclean or in inadequately lit conditions. Talent will get a 10-minute break during their contracted playing time.
17. Talent will not sign any additional contracts. The Creative Casting Agency will be contacted immediately by Client or Talent if additional services will be required.
18. Client does not actually have to use talent's services.
19. Talent will bring their own sound equipment
20. Client will provide an awning, tent or canopy to protect the band and their equipment from the sun during their "set."
21. Any controversy or claim arising out of or in relation to this Agreement shall be resolved by arbitration. The parties shall have the right to engage in pre-hearing discovery in connection with such arbitration proceedings. The parties agree hereto that they will abide by and perform any award rendered in any arbitration conducted pursuant hereto, that any court having jurisdiction thereof may issue a judgment based upon such award and that the prevailing party in such arbitration and/or confirmation proceeding shall be entitled to recover its reasonable attorneys' fees and expenses. The arbitration award shall be final, binding and non-appealable.
